Supply, Installation & Commissioning of Grid connected Rooftop Solar Photovoltaic Systems in Residential premises including five years of comprehensive maintenance in the State of Sikkim under PM Surya Ghar: Muft Bijli Yojana
"Domestic Content Requirement" (DCR) of solar cell and modules is mandatory as per guidelines of MNRE
Time and place of submission of Application
The vendor may submit their application along with requisite document to the office of the Director, Sikkim Renewable Energy Development Agency (SREDA) D.P.H. Road, SREDA Bhawan, Gangtok -737101 on all working days except Holidays from 10.00 Hrs to 4.30 Hrs. Application received through e-mail will not be accepted.
Eligibility Criteria:
* The firm will install rooftop solar plants fulfilling minimum technical standards and specifications issued by the MNRE.
* The firm has sufficient (at least 3) technical manpower trained in the skills required to execute the work of installation of rooftop solar plants and the firm should have experience of installation of at least 10 kWp SPV plant (Cumulative). Supportive documents to be submitted.

	* The vendor shall submit Format of Declaration (Annexure-1) attached hereto duly filled & signed with company seal on every pages of the document.

5	Vendor Registration Process (Annexure-2):
	* The vendors willing to execute the projects through the National Portal can get registered with respective DISCOM by submitting an application along with a declaration in the format given at www.solarrooftop.gov.in and depositing Rs. 2,50,000/- valid for at least 5 years.
	* Vendors can submit the application at the office of the Director, Sikkim Renewable Energy Development Agency(SREDA), D.P.H Road., SREDA Bhawan, Gangtok -737101, and their names will be included in the list of empaneled vendors within a period of 1 month from the date of submission of the application. The empanelment list will be updated monthly.
	* The DISCOM will upload the details of the registered vendors on the National Portal and the vendors will receive a registration mail. The vendors can log in to the National Portal with their PAN number and Mobile number (used by DISCOM for registration) and enter the product rates and contact details. The details entered by the vendor will be visible to the consumer submitting application to the concerned DISCOM for rooftop solar.
6	Process of Empanelment : After obtaining the applications, SREDA will verify the submitted documents for qualification. SREDA will ask the qualified agencies to submit the necessary Performance Bank Guarantee. After getting PBG from the agencies, a list of empanelment of vendor will be uploaded to the portal.
7	SREDA reserves the right to accept or reject any or all applications at its discretion without assigning any reason whatsoever and does not bind itself to accept the application.
8	Performance Bank Guarantee (PBG)
	The qualified agencies have to submit a performance Bank Guarantee of Rs. 2.5 lakhs valid for five years to SREDA. Format of PBG is enclosed (Annexure-3). The Security money so retained shall not bear any interest whatsoever.

The vendors can now log in to the National Portal with PAN No. and mobile number (used by DISCOM for registration) and enter the product rates and contact details. The details entered by the vendor will be visible to the consumer submitting an application to the concerned DISCOM for rooftop solar.
